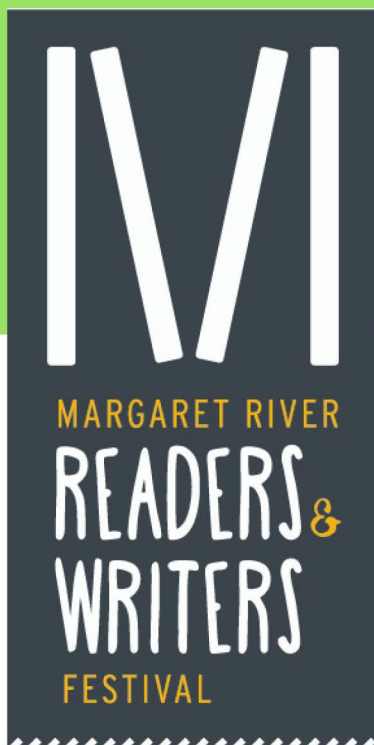

CONDITIONS OF ENTRY

1. Entry is open to artists over 17, residing in West Australia. The entry fee is \$30 and is non-refundable.
2. All works will be exhibited on the grounds of Voyager Estate and must be self-supporting without penetrating the ground. The pole has to be stable with no trip hazards, weather resistant as it will be on display in possible wet weather conditions and wind resistant. The base of the pole must be low profile with an area exposed at the bottom all around to allow for extra weight to be added if required – extra weights will be provided if required- Please see side bar for suggested bases.
3. Recommended dimensions - Max Height 2.4mt, Max Diameter 30cm, Max weight 50kg
4. Artworks must be for sale at a realistic price, with a 20% commission going to Arts Margaret River.
5. The pole and base are to be delivered to Arts Margaret River at The Community Centre on Tunbridge St. between 10am & 4pm, Mon 14th to Thur 17th May. From there your work will be transported to Voyager for installation. If your pole has any protrusions, please allow possible removal to avoid damage during installation
6. Arts Margaret River reserves the right to refuse any artwork based on merit, suitability for general public viewing or safety concerns.
7. By entering, the artist agrees to their work being reproduced in print, film and digital format for promotion, funding appraisals and acquittals, online and in the media.
8. While all due care is taken with exhibits, Arts Margaret River accepts no liability for any loss or damage while the exhibits are in its custody. Artists are responsible for insuring their work.
11. The judge's decision is final and no correspondence will be entered into.
12. Winners will be announced. at the Visual Stories Launch on Wed 30th May 5-7pm at Voyager Estate. Artists & friends are invited to the launch.
